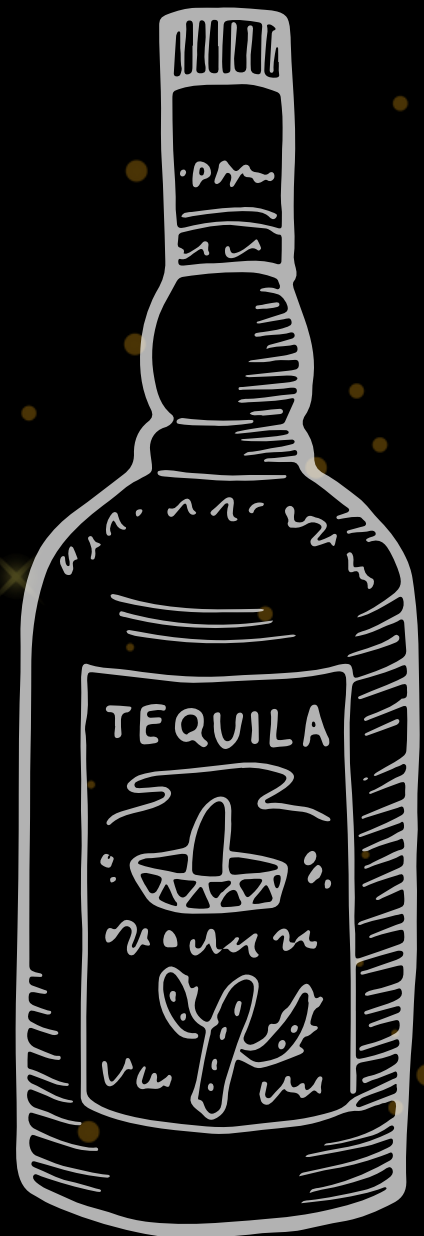

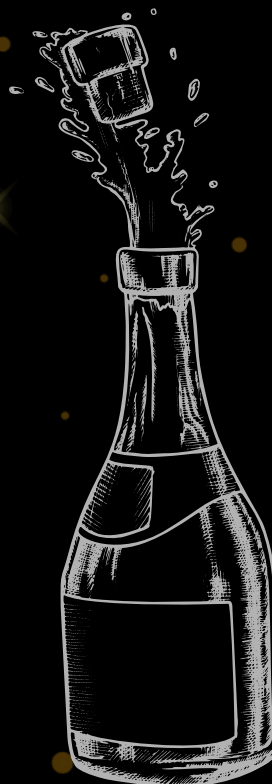

TERMS AND CONDITIONS

PAYMENTS

Payment Method: We utilize GoCardless for all payments. The first invoice will be sent via GoCardless, and payment must be made through this platform.

Payment Terms:

·**Deposit for Date Securing:** The deposit must be paid within 7 days from the date of invoice to secure your booking. Your reservation will only be confirmed upon receipt of the deposit. The payment of the deposit constitutes acceptance of the terms and conditions stated herein.

·**Remaining Balance:** The remaining balance is to be paid prior to the event, as outlined in the quote, unless otherwise agreed upon in writing. If payment is not received within 15 days, a 10% interest charge will be applied to any outstanding invoices.

TOKENS

If the client wishes to use tokens (one token per cocktail) to distribute to their guests, guests are responsible for presenting the token to the bar in exchange for a cocktail. We accept no responsibility for lost tokens. If tokens are not used on the night of the event, this will not affect the final invoice and cannot be applied to another event.

CANCELLATIONS

In the event of cancellation, the deposit is non-refundable. The event can be postponed for up to 6 months to arrange a new date.

EVENT TIMINGS

Bar opening hours, setup, and clearing times must be agreed upon in advance, with sufficient time allowed to vacate the venue after the event. You must inform us of any time constraints, parking restrictions, or height restrictions.

We require one hour for the bar setup within a 24-hour time slot before the event starts, and one hour for clearing away within a 24-hour time slot after the event. The bar will be left clean and closed at the venue address if necessary.

If the event does not directly precede or follow the bar setup or breakdown, additional travel costs may apply to the final invoice.

ADDITIONAL GUESTS

If the number of guests increases beyond the pre-agreed amount, an entrance fee of £40 per person will be charged, which includes 4 cocktails per person. If a paid bar is involved, the minimum spend may increase. We must be informed at least 2 days in advance.

VENUE

The client is responsible for the condition of the bar and its contents. The client is also responsible for liaising with the venue to ensure it is suitable for bar setup. The Cocktail Broker accepts no responsibility for any delays on the day of the event if this becomes an issue.

DRINK CHOICES

Drink selections must be finalized 14 days prior to your event.

VIP WRISTBANDS

If the client chooses the "all-inclusive" package, their guests will receive VIP wristbands. Should more guests arrive than initially indicated, we will invoice for the additional guests post-event.

DRINK RESPONSIBLY

Bookings may only be made by individuals aged 18 and over. It is illegal for anyone under 18 to purchase, attempt to purchase, or consume alcohol at the event. The Cocktail Broker recommends that anyone who appears to be under 25 bring photographic ID or proof of age, or we will not be able to serve them.

The Cocktail Broker reserves the right to refuse service to anyone at the event who appears excessively intoxicated or behaves threateningly or abusively toward staff, customers, or other guests.

The Cocktail Broker will also refuse service to anyone who purchases or attempts to purchase alcohol for someone under 18 or someone who has previously been refused service. The decisions regarding such matters will be made by The Cocktail Broker staff and will be final.

TRANSPORT

Mileage charges may apply for events outside the designated catchment area; this will be agreed upon at the time of booking with the client. Hotel accommodation may be requested for staff if the event location is far away.

SERVICE TIMES

We typically offer a 4-hour bar service; however, if the client wishes for us to stay longer on the evening of the event, this can be discussed with the manager. Any extra charges incurred will be discussed with the bar manager during the event.

MINIMUM SPEND

Depending on the event location and the number of guests, the client will be asked to commit to a minimum spend amount, which must be paid either prior to the event or on the day itself. The minimum spend will be agreed upon before the booking.

If the minimum spend is not met, or additional charges are incurred during the event, this amount can be paid on the day of the event. If payment is not received on the day, the remaining balance will be invoiced. Payment must be completed within 2 weeks following the event date. Failure to do so will result in legal action to recover the outstanding amount.

LOSS AND DAMAGE

The client is responsible for any loss or damage to rental equipment and must settle this within 14 days of the event. Glassware is also included in the rental equipment and is subject to the same conditions. However, The Cocktail Broker acknowledges that glasses may be accidentally broken and is willing to waive any losses or damages if they do not exceed 5% of the total number of glasses provided at the event.

Our price quotations are valid for 10 days from the date of issue due to high demand.
